Posting Signs and Notices

Section 2.1.6 of the Hearing Policies and Procedures outlines the Department's Instructions for Posting Signs and Notices. Please refer to the Hearing Policies and Procedures, available on the Department's website, for complete information pertaining to your application or license.

2.1.6 Posting Signs and Notices

- **2.1.6.1** <u>Posting Sign Location Posting signs must be placed in a conspicuous place on the licensed premises or proposed licensed premises which is clearly visible to the public.</u>
- **2.1.6.2** <u>Posting Sign Requirements</u> The requirements of a posting sign are as follows:
 - (i) The sign posted must be sturdy and white, not less than 22 inches wide and 26 inches in height, with letters not less than one inch in height.
 - (ii) The Department will provide the Applicant/Licensee with content to be included on the posting sign. The sign must be posted with all required content at all times during the posting period.
 - (iii) The sign shall indicate the name and address of the Applicant/Licensee and any partners or officers of the Applicant/Licensee. The sign may be posted inside of the proposed premises but must be posted so as to be conspicuous and plainly visible to the general public.
 - (iv) A map of the Designated Area must be attached to the sign and must indicate the area in which petitions for or against the Application may be circulated and from which witnesses may testify.
 - (v) The sign must inform the public that petitions for evening hearings must be filed fifteen (15) days before the scheduled hearing date.
- **2.1.6.3** <u>Failure to Adhere to Posting Requirements</u> An inspector from the Department may make random inspections to ensure that posting requirements are met. If the Applicant/Licensee fails to adhere to the posting requirements, the Director, in his or her discretion, may reschedule the hearing and require an additional period of posting or deny the Application.
- **2.1.6.4** <u>Publication Newspaper of General Circulation</u> For hearings related to new liquor, new marijuana, new cannabis consumption, and new cabaret licenses, the Department will publish notice of the public hearing in a newspaper of general circulation as required by statute and ordinance for the specific type of public hearing occurring. The publication shall identify the same information contained in posted notices, with the exclusion of the map of Designated Area.
- **2.1.6.5** <u>Publication Department Website</u> The Department may post notice of the public hearing on its website and will make reasonable efforts to ensure that postings are current.
